



# Greater Mekong Subregion Cross Border Transport Facilitation Agreement (CBTA) 'Early Harvest' Implementation

Training Module Four – Using the Register

Developed under Project TA-8748 REG Sub-project 2 (SP2) - Support for Implementing the Action Plan for Transport and Trade Facilitation in the GMS

Supported by the Asian Development Bank and Australian Department of Foreign Affairs and Trade

- Based on the CBTA 'Early Harvest' MOU, each GMS country can issue up to 500 GMS Motor Vehicle Temporary Admission Documents (TADs) for goods and passenger vehicles owned and operated by licensed transport operators from their country
- Each Permit and TAD has a unique reference number (see separate training modules on Permits and TAD issuance)
- These reference numbers and other particulars must be recorded in a list or **Register of Permits and TADs** (an Excel Workbook shared by all countries) in line with Article 4 of the 'Early Harvest' MOU
- Based on Article 4, each GMS country must communicate its updated national Register of licensed road transport operators holding Permits and TADs for cross-border road transport operations at the start of every quarter (i.e. every 3 months starting 31 May 2018) to the Joint Committee
- This may be done via ADB (by e-mail to <u>kanyass@adb.org</u>) for verification and onward dissemination to the other Contracting Parties
- The Register will be subject to annual review and modification, as appropriate, in line with Articles 2 and 5 of CBTA Protocol 3

- A Register template for the start of 'Early Harvest' operations was endorsed at the Fifth Joint Committee Meeting
- It takes the form of an Excel Workbook and must be completed in English
- However, for each English row, countries may also include a corresponding row for recording entries in national languages
- Countries are advised to do this for the purposes of 'correspondence' and traceability (since English language translations and spellings may vary)

- The full Register starts with column A and goes through to column AJ,
   i.e. 36 columns in total
- If 500 permits and TADs are issued, there will be up to 500 English and 500 national language rows
- A truncated version of the Register format is shown below
  - o The yellow columns (B to G) record the Permit details
  - The grey columns (A and H) record the language and TAD number respectively
  - o The blue columns (I to R) record the details of the transport operator/vehicle owner
  - o The orange columns (S to AJ) record the vehicle details
- All particulars recorded on the Register should match those on the Permits and TADs

- The TAD number must follow the format agreed between Contracting Parties. Following the words 'TAD-GMS/' the country code is that of the distinguishing sign for motor vehicles of that country: Cambodia: KH, People's Republic of China: CHN, Lao PDR: LAO, Myanmar: MYA, Thailand: T, and Vietnam: VN
- The TADs should be numbered between 0001 and 0500 i.e. TAD-GMS/KH-0001 or TAD-GMS/VN-0500 (as examples of the first TAD for Cambodia and the last TAD for Vietnam)
