


P4I's specialist areas are policy and regulation, prioritisation and planning, and procurement.


Embedded across these areas are the cross-cutting priorities of gender equality, social inclusion, disaster risk reduction and climate change.

Supporting interconnectivity and cross-border initiatives



Laos Economic Connectivity Project

- Supporting the South-East Asian Regional Economic Corridor and Connectivity (SEARECC) Project
- Improving east-west connectivity in the Mekong subregion
- Implementation of a project featured on the Initial Pipeline of ASEAN Projects
- Partnering with the Government of Laos, World Bank, and European Investment Bank

Enhancing Container Processing Procedures in ASEAN

- Identify and understand container processing issues faced by ASEAN nations and shipping lines, including the impact of COVID-19
- Determine short-term and long-term solutions to solve these issues
- Supporting the ASEAN Secretariat

Cross-Border Scoping Study

- Inform P4I's approach to land transport cross-border infrastructure in Southeast Asia
- Focused on supporting bilateral and trilateral engagement, and regional and subregional cross-border initiatives

Maritime and Logistics Scoping Study

- Aims to enhance P4I's understanding of the maritime and logistics sector in Southeast Asia
- Identify areas where P4I can support in improving the planning, performance, and delivery of maritime projects in ASEAN
